## OFFICE DIRECTIONS

### **CHESTERFIELD, MO OFFICE**

- This office is located in the Chesterfield Valley, midway between Interstate 270 and the Missouri River. The building is located on the Northwest corner at Hwy 40/61 and Boone's Crossing (Exit #17). Located in the "St. Louis Cosmetic Surgery and Spa" building on the North Outer Road.

### **O'FALLON, MO OFFICE**

- Hwy. 40/61 West over the "Daniel Boone Bridge", Exit at Hwy. K and Turn **RIGHT** onto the Highway. Go approximately 1.2 miles and Turn **LEFT** onto Market Center Blvd. (Located in Large Medical Bldg. that says "St. Louis Orthodontic Group.")
- Hwy. 40/61 East, Exit at Hwy. K and Turn **LEFT** onto the Highway. Go approximately 1.2 miles and Turn **LEFT** onto Market Center Blvd. (Located in Large Medical Bldg. that says "St. Louis Orthodontic Group.")
- Interstate 70 West, Exit at Hwy. K and Turn **LEFT** onto the Highway. Go approximately 4.7 miles and Turn **RIGHT** on Market Center Blvd. (Located in Large Medical Bldg. that says "St. Louis Orthodontic Group.")
- Interstate 70 East, Exit at Hwy. K and Turn **RIGHT** onto the Highway. Go approximately 4.7 miles and Turn **RIGHT** on Market Center Blvd. (Located in Large Medical Bldg. that says "St. Louis Orthodontic Group.")

### **WENTZVILLE, MO OFFICE**

- Hwy. 61 Northwest, Exit at MO-A (Wentzville Parkway) and Turn **LEFT** onto the Wentzville Parkway (MO-A). Go approximately 1.2 miles and Turn **LEFT** onto Schroeder Creek Blvd. We are located in the building on the corner of Schroeder Creek and the Wentzville Parkway.
- Hwy. 61 Southeast, Exit at MO-A (Wentzville Parkway) and Turn **RIGHT** onto the Wentzville Parkway (MO-A). Go approximately 1.2 miles and Turn **LEFT** onto Schroeder Creek Blvd. We are located in the building on the corner of Schroeder Creek and the Wentzville Parkway.
- Interstate 70 East, Take Exit #208 and Turn **LEFT** onto the Wentzville Parkway. Go approximately 1.5 miles and Turn **RIGHT** on Schroeder Creek Blvd. We are located in the building on the corner of Schroeder Creek and the Wentzville Parkway.
- Interstate 70 West, Take Exit #208 and Turn **RIGHT** onto the Wentzville Parkway. Go approximately 1.5 miles and Turn **RIGHT** on Schroeder Creek Blvd. We are located in the building on the corner of Schroeder Creek and the Wentzville Parkway.

### **TROY, MO OFFICE**

- Hwy. 61 Northwest, Take the MO-47 (Troy, Winfield) Exit and Turn **LEFT** onto Hwy. 47. Go approximately 1 mile and Turn **RIGHT** onto Prospect Drive. Turn **LEFT** onto Troy Square. (Located in the Troy Professional Building).
- Hwy. 61 Southeast, Take the MO-47 (Troy, Winfield) Exit and Turn **RIGHT** onto Hwy. 47. Go approximately 1 mile and Turn **RIGHT** onto Prospect Drive. Turn **LEFT** onto Troy Square. (Located in the Troy Professional Building).
